TAIPEI, Taiwan and MILPITAS, Calif., January 28, 2019 – Silicon Motion Technology Corporation (NasdaqGS: SIMO)("Silicon Motion" or the "Company"), a global leader in designing and marketing NAND flash controllers for solid state storage devices, confirms today its quarterly cash dividend.

On October 29, 2018, the Board of Directors of the Company declared payment of an annual dividend of US\$1.20 per ADS¹, equivalent to US\$0.30 per ordinary share, which will be paid in four quarterly installments of \$0.30 per ADS, equivalent to US\$0.075 per ordinary share. According to the previously announced record and payment dates, the next quarterly installment will be paid on February 27, 2019 to all shareholders of record on February 15, 2019. Our depository bank's DR Books will be closed for issuance and cancellation on February 15, 2019.
